**ADDENDUM NUMBER TEN TO REQUEST FOR STATEMENT OF QUALIFICATIONS
(RFSQ) CMS 04-011 FOR WRAPAROUND APPROACH SERVICES**

Addendum Number Ten is issued by the County of Los Angeles Department of Children and Family Services (DCFS) to all holders of the Wraparound Approach Services RFSQ CMS 04-011 released on December 23, 2010. Addendum Number Ten amends sections of the RFSQ as provided below:

The following changes are being made to the RFSQ:

- I. RFSQ, Part A – Overview, Section 4.0 – Procurement Timetable, Sub-section 4.1 is amended to read as follows:
 - 4.1 The following timetable represents the County's best estimate of the schedule that shall be followed in this procurement process. County reserves the right, at its sole discretion, to adjust this schedule, as it deems necessary. Notification of any adjustment to the timeline shall be provided to any prospective contractor who requests a copy of the RFSQ.
 - Release RFSQ: December 23, 2010
 - Submission Deadline for Request for Solicitation Requirements Review: January 13, 2011
 - RFSQ Conference: January 6, 2011
 - Questions and Answers Released: January 20, 2011
 - Deadline for SOQ Submission: February 11, 2011
 - Anticipated Contract Start Date: on or about ~~November 1, 2011~~ May 1, 2012

- II. RFSQ, Part A – Overview, Section 9.0 – Contract Period and Recommendation of Award is amended to read as follows:

9.0 CONTRACT PERIOD AND RECOMMENDATION OF AWARD

The initial term of each proposed Contract will be 12 months with one one-year option to renew the Contract at the sole option of the COUNTY for a total of two years. Contract is scheduled to commence on or about ~~November 1, 2011~~ May 1, 2012, or after approval by the County's Board of Supervisors, whichever is later. Refer to Part G, Sample Contract (Unique Terms and Conditions, Section 2.0, Term). However, the County shall solely determine whether or not to enter into any contract as a result of this RFSQ and the start date may vary from that stated.

Except as provided by this addendum, all other terms and conditions of the RFSQ remain unchanged.
