- 23-E.** Recommendation as submitted by Supervisor Yaroslavsky: Proclaim May 2012 as “Wellness Month” throughout Los Angeles County and launch the “Countywide Fitness Challenge” campaign for all employees and their families; encourage Department Heads and Wellness Managers to support and market the program to their employees and strive for 100% participation; encourage all employees to support and attend the May 15, 2012 Kick-Off event at the Music Center - Performing Arts Center of Los Angeles County and/or the May 19, 2012 activity Kick-Off event at Frank G. Bonelli Regional Park in San Dimas; and waive the following fees, excluding the cost of liability insurance:

Waive the \$750 facilities fee and parking fees in the amount of \$2,000 for 100 vehicles, at the Music Center Garage (parking lot 14) for the participants of the Kick-Off event on May 15, 2012;

Waive the \$500 facilities fee and parking fees in the amount \$3,000 for 300 vehicles at Frank G. Bonelli Regional Park on May 19, 2012;

Waive the \$1,715 facilities fee and parking fees in the amount of \$3,000 for 300 vehicles at Santa Fe Dam Recreation Area on June 16, 2012;

Waive \$1,015 facilities fee and parking fees in the amount of \$1,800 for 300 vehicles at Kenneth Hahn State Recreation Area on September 15, 2012; and

Waive \$410 facilities fee and parking fees in the amount of \$3,000 for 300 vehicles at Burton W. Chace Park on September 29, 2012.
